If the last date of receipt of tender is declared to be a holiday the next working day shall remain valid for the purpose.

The Limited Tender should consist of two Bids – The technical bid and the financial bid. Both must be submitted in two separate envelopes to be sealed and put in a single main cover.

The outer main cover should be super scribed “**TENDER FOR THE SUPPLY OF**”
The Bidding Firms should give their complete address on the bottom left corner of the Main Cover. The main cover should also be sealed properly.

The Earnest Money along with all technical details is mandatory to be kept alongwith Technical Bid as per enclosed ANNEXURE-A.

The Financial Bid enclosed as per ANNEXURE-B must contain the price details.
Bids qualifying technically (in all respect) shall be considered for financial aspects.
