TERMS AND CONDITIONS

1. (a) The rates should be quoted F.O.R. ICAR NRC Mithun, Medziphema.
(b) Sample for quality may kindly be provided along with the quotations.
2. The Earnest Money Deposit (EMD), of Rs.4,000/- (Rupees four thousand) only in the form of DD in favour of the Director, NRCM payable at SBI, Medziphema Branch must be submitted along with the technical bid, failing which the proposal shall be rejected. No interest is payable for the EMD deposited. The EMD deposited is liable to be forfeited, if the tenderer withdraw or amends or impairs or derogates from the tender in any respect within the period of validity of their tenders. If the successful tenderer fails to furnish the performance security as required in the contract within the stipulated period, the Earnest Money shall be liable to be forfeited. EMD of the unsuccessful tenderers shall be returned after finalization of the tender.
3. The centre is registered with the Department of Scientific & Industrial Research (DSIR) for purpose of availing customs duty exemption in terms of Government Notification No 51/96- Customs dated 23 July 1996 and Central Excise Duty Exemption in terms of Government Notification No 10/97- Central Excise dated 1 March 1997.
